**David Ryan Polgar** is a pioneering tech ethicist, Responsible Tech advocate, and expert on ways to improve social media and our information ecosystem, along with increasing the ethical considerations regarding emerging technologies. He specializes in uniting a diverse range of stakeholders in order to tackle complex tech and society issues, cultivating conducive environments for forward progress.

David is the founder of All Tech Is Human, a non-profit organization synonymous with the Responsible Tech movement that is building a global, multistakeholder, multidisciplinary network that improves our ability to understand and grapple with difficult issues related to social media, AI, and emerging technology. As the leader of All Tech Is Human, he has created a unique grassroots-power model that is uniting thousands of individuals across the globe to understand values, best practices, and best pathways

forward. His work building a large and diverse community of individuals coming together to tackle wicked problems was recently covered in the MIT Technology Review and will be an entire chapter in Greg Epstein's upcoming book, Tech Agnostic: How Technology Became the World's Most Powerful Religion, and Why It Desperately Needs a Reformation.

An international speaker with rare insight into building a better tech future, David has been on stage at Harvard Business School, Princeton University, Yale School of Management, Statcom Summit (Istanbul), The School of the New York Times, TechChill (Latvia), The Next Web (Netherlands), FutureNow (Slovakia), Infoshare (Poland), and many more. His commentary has appeared on CBS This Morning, TODAY show, BBC World News, MSNBC, Fast Company, The Guardian, SiriusXM, Associated Press, LA Times, USA Today, and more.

The main throughline throughout David's work is that we need a collaborative, multistakeholder, and multidisciplinary approach that is agile and fast-moving in order to build a tech future that is aligned with the public interest.

Johnson Billips received her Bachelor of Arts in anthropology and in international studies from Yale University. She received her Juris Doctor and Master of Laws in international and comparative law from Duke University.

She is the Senior Practice Manager in Responsible AI heading the worldwide practice dedicated to customer engagement. Diya has honed her skills in scaling products for acquisition, spearheading initiatives for inclusion, diversity, and equity, leading operational transformation across various industries, and leveraging the historical and social contexts that influence her approach to responsible and inclusive AI/ML (artificial intelligence/machine learning) products.

She grew up in the Bronx and Harlem, and by third grade knew she wanted to pursue a career in computer engineering when she received her first computer—a time when not every household had a computer. Diya went on to pursue her degree in computer science at Spelman College, studied the Management of Technology at New York University, and studied AI & Ethics at MIT Sloan School of Management and Harvard University Professional School.
