#### **Overview of InterAction**

# **NGO Fora in Humanitarian Settings: What They Do**

NGO fora are crucial coordination bodies that facilitate effective collaboration, not only amongst NGOs but across other response actors, including the United Nations (U.N.) and local, national, and international government stakeholders, to ensure that multisectoral aid is reaching the most vulnerable in an efficient and timely manner. These fora serve as platforms for NGOs to exchange information, share expertise, establish common ways of working, and collectively engage with external stakeholders. They support humanitarian trends analyses and risk forecasting, contribute to minimizing and mitigating operational risks, advance results-based and NGO-led responses, and serve as a key negotiator and external liaison for bureaucratic and administrative impediments to aid delivery. Critically, they provide an instrumental link between the voices of affected populations and humanitarian leadership bodies.

InterAction is committed to supporting NGO for a across the globe in expanding their capacities to foster collective accountability and undertake collective action. Specifically, InterAction works to maintain and strengthen a global community of practice, providing governance advice and expertise, supporting advocacy, and promoting the pivotal role for a play in the broader humanitarian community. InterAction's community of practice roster currently spans over 35 for a in humanitarian and nexus contexts worldwide.

## Services InterAction Provides to NGO Fora and Forum Directors1:

#### **GOVERNANCE ADVICE & EXPERTISE**

- ▶ Provides a daily help desk providing one-on-one coaching, technical support, and referral services.
- ▶ Develops minimum standards and guidelines for forum host agencies and best practices for forum donors.
- Avails and regularly updates a robust platform of tools and templates for forum directors and steering committees
- Conducts ad hoc field missions to support NGO coordination in humanitarian settings.
- ► Supports research initiatives aimed at affecting change to the humanitarian system in view of enhancing principaled responses, bringing accountability, and promoting resilience and recovery.

➤ Cultivates and curates vibrant discussion and learning between NGO forum directors/leadership, including through discussion groups, regular "All Forum" meetings, ad hoc meetings between select fora with common interests, and annual in person meetings.

## ADVOCACY SUPPORT

- ▶ Supports identification and development of key advocacy intiaitives toward:
  - U.S. government based/facing stakeholders and broader humanitarian leadership and decisionmaking bodies.
  - The Inter-Agency Standing Committee (IASC), including Principals, Deputies, the Emergency Directors Group (EDG), the Operational Policy and Adovcacy Group (OPAG), and various task forces.
  - Multistakeholder platforms, including through it's co-leadership role of the Grand Bargain Facilitation Group.
- ▶ Fosters connections between country-based NGO fora and D.C.-based stakeholders including:
  - Member-based working groups.
  - o The U.S. government (State Departement, USAID, Congress, National Security Council).
