Providing Holistic Care in Times of Crisis

As climate change, displacement, and inequality place increasing strain on communities, frontline health systems must evolve to reach those most at risk. This joint panel brings together ADRA International and Americares to explore how innovative mobile health outreach and climate-informed primary healthcare can adapt to rapidly changing community needs while expanding access to essential health services. Drawing on ADRA International's experiences supporting Venezuelan migrants affected by displacement in Colombia and Americares' climate adaptation efforts with primary healthcare centers in the Philippines, panelists will share practical, scalable solutions for delivering equitable and community-centered primary care. The discussion will highlight how locally-led, co-created solutions can strengthen integrated health service delivery, build community resilience, and help health systems better respond to the growing challenges of climate change and displacement.

played a key role in the expansion of the Climate Resilience for Frontline Clinics Toolkit and the development of the Climate Health Equity for Community Clinics Program.

Locally-led Resource Mobilization and Governance – A Strategy for the Future

The Forum

What changes are needed for emergency response funds to become sustainable efforts? What capacities and strategies do local organizations need to sustain their source of income? What do donors and INGOs need to build—or let go of—to shift decision-making power locally? In this joint presentation, the Unitarian Universalist Service Committee and Oxfam America will share examples and discuss forward-looking implications for humanitarian resource mobilization and partnership models. UUSC will share practical lessons of how locally led resource mobilization – through pooled funds, community-led processes to inform resourcing strategy – supports agency, directs resources to where they need to go and is sustainable in responding to humanitarian and human rights crises. Oxfam will share highlights of emerging approaches of locally-led financing from its Emergency Response Fund Agility pilot to scale locally governed emergency response funding, including flexible financing, and foster shared risk management, women’s organization participation, and locally designed accountability systems.

Senior Partnership Officer for International Justice and Accountability, Unitarian Universalist Service Committee (UUSC)

Myra is the Senior Partnership Officer for International Justice and Accountability at Unitarian Universalist Service Committee (UUSC) and a board of director for the U.S Campaign for Burma. She is a Karen human rights activist from Karen State, Eastern Burma. Myra was an internally displaced person and a refugee before she resettled in the United States. Since a young age, she has been a community organizer. In the past two decades, Myra has been engaged with various human rights and political issues in Burma while serving her community and Burmese diaspora in the United States focusing on the United States’ Burma policy, promotion of human rights, and an inclusive democracy that includes all ethnic and religious minorities.



Namalie Jayasinghe

Senior Researcher, Humanitarian, Oxfam America

Namalie is the Senior Researcher, Humanitarian at Oxfam America, where she leads strategic research on humanitarian action, localization, and gender justice. Previously, she served as Oxfam America’s Senior Researcher for Gender and Women’s Rights, contributing to the organization’s learning agenda on intersectional feminism. Before joining Oxfam, Namalie was a postdoctoral fellow at Kadir Has University in Istanbul, researching discourses on violence

against women in Sri Lanka and Turkey. She holds a PhD in International Relations from American University, where her research examined the gendered impacts of natural disasters in Sri Lanka, as well as degrees from New York University and the London School of Economics. Her work spans Asia, West Africa, and the United States, advancing women's leadership and locally led humanitarian action.
